The ISO/IEC FCD 9075-3 SQL/Call Level Interface Editing Meeting completed its business on the 19th of February 1999 with the following resolution which was passed unanimously:

The delegates to the editing meeting recommend to the SC32 Secretariat that the output document produced by the editor be submitted for FDIS ballot as soon as possible..

211 comments resulted from the ballot, of which 78 are categorized as Major Technical comments, 96 as Minor Technical comments, 6 as Major Editorial comments, and as 31 Minor Editorial comments.

The Editing Meetings managed to resolve all of these 211 Ballot Comments and a small number of additional problems discovered during the editing process.

At the close of the final meeting there were no outstanding known problems with the part under ballot.

We hope therefore that the SC32 secretariat will be able to initiate a Final DIS Ballot for these parts immediately the final text is available.

The Editor, Jim Melton, plans to ship camera ready copy on Friday, May 07, 1999 to the SC32 Secretariat for the two-month FDIS ballots on this SQL part.
